Weight: 118 lbs. The maximum number of starters for the Darley Alcibiades will be limited to fourteen. In the event that more than fourteen fillies pass the entry box, the fourteen starters will be determined at that time by highest earnings. Starters to be named through the entry box by usual time of closing. A gold julep cup will be presented to the owner of the winner. A silver julep cup will be presented to the winning trainer and jockey. The owner of the winner will receive a 2010 non-transferable no guarantee season to Rockport Harbor. The breeder of the winner will receive a 2010 non-transferable no guarantee season to Discreet Cat. The first four finishers in the Darley Alcibiades are automatically made eligible for the Ashland Stakes of 2010 as to nomination fees.
