12th Running Of The First Lady "Win and You're In Filly & Mare Turf Division" \$400,000 (Grade I)

FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD By subscription of \$200 each, which should accompany the nomination or by Supplementary Nomination of \$20,000 by time of entry (Includes entry and starting fees), \$2,000 to enter and an additional \$2,000 to start, with \$400,000 guaranteed, of which \$240,000 to the owner of the winner, \$80,000 to second, \$40,000 to third, \$20,000 to fourth, \$12,000 to fifth and \$8,000 to be divided equally among sixth through last. In the event this race is taken off the turf, due to unsafe racing conditions, the horse that wins the 'off the turf' race will NOT receive an automatic qualifying position to enter the Breeders' Cup Filly & Mare Turf. Weight: Three-year-old fillies, 120 lbs.; Older fillies and mares, 123 lbs. The maximum number of starters for the First Lady will be limited to twelve if on the Haggin Course or ten with two also eligibles if on the Keeneland Course. In the event that the race overfills the starters will be determined at that time with preference given to graded or group turf stakes winners, graded stakes winners, then highest turf earnings in 2009. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. A silver julep cup will be presented to the winning trainer and jockey.
