FOR THREE YEAR OLDS By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$6,250 by time of entry (Includes entry and starting fees). \$625 to enter and an additional \$625 to start, with \$125,000 guaranteed, of which \$75,000 to the owner of the winner, \$25,000 to second, \$12,500 to third, \$6,250 to fourth, \$3,750 to fifth and \$2,500 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a graded or group stakes on the turf allowed 2 lbs.; \$45,000 twice in 2009, 4 lbs.; three races other than maiden or claiming, 6 lbs. The maximum number of starters for the Bryan Station will be limited to twelve if on the Haggin Course or 10 with two also eligibles if on the Keeneland Course. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners, then highest 2009 earnings. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner.
