**FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD** By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 by time of entry (Includes entry and starting fees). \$500 to enter and an additional \$500 to start, with \$100,000 added, of which 60% of all monies to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally among sixth through last. Weight: Three year olds, 122 lbs.; Older 124 lbs.; Non-winners of a graded stakes on the turf in 2009 allowed 2 lbs.; \$45,000 twice since April 3, 4 lbs.; \$45,000 since April 4, 6 lbs. The maximum number of starters for the Buffalo Trace Franklin County will be limited to twelve if on the Haggin Course or ten with two also eligibles if on the Keeneland Course. In the event that the race overfills the starters will be determined with preference given to graded stakes winners, then highest 2008-2009 earnings. Starters to be named through the entry box by the usual time of closing. A set of four silver julep cups will be presented to the owner of the winner.
