**FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD** By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$6,250 by time of entry (Includes entry and starting fees). \$625 to enter and an additional \$625 to start, with \$125,000 guaranteed, of which \$75,000 to the owner of the winner, \$25,000 to second, \$12,500 to third, \$6,250 to fourth, \$3,750 to fifth and \$2,500 to be divided equally among sixth through last. Weight: Three year old fillies, 121 lbs., Older fillies and mares, 125 lbs. Non-winners of a Grade I or II over nine furlongs in 2009 allowed 3 lbs.; a graded stakes over nine furlongs in 2008-2009, 5 lbs. The maximum number of starters for the Rood and Riddle Dowager will be limited to twelve, with two also eligibles. In the event that the race overfills the starters will be determined at that time with preference given to graded stakes winners, then highest 2008-2009 earnings. Starters to be named through the entry box by the usual time of closing. A set of four silver julep cups will be presented to the owner of the winner.
