FOR FILLIES, TWO YEARS OLD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 by time of entry (Includes entry and starting fees). \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. In the event this race is taken off the turf, due to unsafe racing conditions, the horse that wins the 'off the turf' race will NOT receive an automatic qualifying position to enter the Breeders' Cup Juvenile Fillies Turf. Weight: 122 lbs. Non-winners of a group or graded stakes on the turf allowed 2 lbs.; a sweepstakes at a mile or over, 4 lbs. The maximum number of starters for the JPMorgan Chase Jessamine will be limited to twelve, with two also eligibles. In the event that the race overfills the starters will be determined at that time with preference by highest earnings. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner.
