FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 by time of entry (Includes entry and starting fees). \$500 to enter and an additional \$500 to start with \$100,000 guaranteed, of which \$60,000 to the owner of the winner. \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to be divided equally among sixth through last. Weight: Three year olds, 121 lbs.; Older, 125 lbs. Non-winners of a Grade I or II over ten furlongs on the turf in 2011 allowed 3 lbs.; a graded stakes over nine furlongs in 2010-2011, 5 lbs. The maximum number of starters for the Sycamore will be limited to twelve, with two also eligibles. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners over nine furlongs, stakes winners over nine furlongs, then highest earnings in 2011. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner.
