## 31st Running Of The Thoroughbred Club of America "Win and You're In Filly & Mare Sprint Division" \$200,000 (Grade II)

**FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD** By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$10,000 by time of entry (Includes entry and starting fees). \$1,000 to enter and an additional \$1,000 to start, with \$200,000 guaranteed, of which \$120,000 to the owner of the winner, \$40,000 to second, \$20,000 to third, \$10,000 to fourth, \$6,000 to fifth and \$4,000 to be divided equally among sixth through last. Weight: Three year old fillies, 122 lbs., Older, 124 lbs. Non-winners of a Grade I in 2011 allowed 2 lbs.; a Grade II in 2011 or \$58,800 since May 1, 4 lbs.; a Grade III or \$45,000 twice in 2011, 6 lbs. The maximum number of starters for the Thoroughbred Club of America will be limited to fourteen. In the event that more than fourteen fillies or mares pass the entry box, the fourteen starters will be determined at that time with preference to graded stakes winners, then highest earnings in 2011. Starters to be named through the entry box by the usual time of closing. A gold julep cup and a Thoroughbred Club of America trophy will be presented to the owner of the winner.
