FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry (Includes entry and starting fees). \$500 to enter and an additional \$500 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: Three year olds, 122 lbs.; Older, 124 lbs. Non-winners of a graded stakes on the turf in 2011 allowed 2 lbs; \$36,000 twice since February 14, 4 lbs.; \$45,000 since April 23, 6 lbs. The maximum number of starters for the Woodford will be limited to twelve, two also eligibles. In the event that the race overfills the starters will be determined with preference given to graded stakes winners, then highest 2010-2011 earnings. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner.
