FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$6,250 at time of entry (Includes entry and starting fees). \$625 to enter and an additional \$625 to start, with \$125,000 guaranteed, of which \$75,000 to the owner of the winner, \$25,000 to second, \$12,500 to third, \$6,250 to fourth, \$3,750 to fifth and \$2,500 to be divided equally among sixth through last. Weight: Three year olds, 122 lbs.; Older, 124 lbs. Non-winners of a graded stakes on the turf in 2009 allowed 2 lbs; a graded stakes in 2009, 4 lbs.; \$45,000 since April 24, 6 lbs. The maximum number of starters for the Woodford will be limited to twelve if on the Haggin Course or ten with two also eligibles if on the Keeneland Course. In the event that the race overfills the starters will be determined with preference given to graded stakes winners, then highest 2008-2009 earnings. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner.
